#### **Booking Terms & Conditions**

#### This is a legal contract so please read carefully

#### Making a Booking:

A deposit of £50 is required to reserve your wedding day date. Only when this payment is received in full, will your wedding day date be reserved.

All deposits are non-refundable in the event of cancellation.

The Bridal Trial date and time must be confirmed back to us in writing (email) to book your trial and payment for the trial should be paid in full to the artist at the trial. You can make this payment by cash or cheque.

If one artist is not enough for your wedding day due to timing, then then a second artist will be charged at  $\pm 100$ 

#### How to Pay:

Payments can be made by cash, cheque, or bank transfer or card

The final payment for your wedding day will be required 7 days before the actual wedding day, unless otherwise agreed.

Parking and congestion charges are to be covered by the client (the bride). You will be charged 45p per mile if you are further than 22 miles from the artist address

#### **Cancellation:**

You have one week after the trial to cancel your booking with us if you are not happy with us after this you may be charged.

In the event of cancellation, you will be charged 50% of the total wedding hair/makeup fees if the booking is cancelled within 8 weeks of the wedding day, or full payment if cancelled after the invoice has been sent which is normally 4 weeks before. this is to cover against any loss of earnings for that day.

#### Postpone:

If you decide to postpone your wedding to a future date, NWMake-up team ltd will endeavour to transfer the booking across to the new date, subject to availability. Should we already have an existing secured booking on such date, no refunds or compensation shall be offered.

If a postponement is mutually agreed, a 50% balance is due on the final balance of the booking
